Motion to open public hearing on the 2016 Truxton Town Budget made by Lloyd Sutton, Jr. and seconded by Stephanie Potter. All in favor.

Public Comments: None.

Motion to close public hearing made by Stephanie Potter and seconded by Lloyd Sutton, Jr. All in favor.
