CALL THE MEETING TO ORDER WITH THE PLEDGE OF ALLEGIANCE.

APPROVAL OF MINUTES

Motion to approve the minutes was made by P.J. Dwyer. Second by Gus Wehbe. All in favor.

PRIVILEGE OF THE FLOOR

Jeff Reakes, Town Superintendent, brought pricing to the Board for the purchase of a new truck. The Truck priced out is a 2019 550 Diesel, dump box, set up for plow, for a price of \$58,078.00. The plow on the 2005 truck is only 2 years old, however the question was brought up should the town advertise the '05 truck with or without the plow? A new plow is \$6,000.00. The '05 truck is used all year long. Bid for new truck was made on 3/20/18 and is valid for 60 days.
