## **Truxton Town Board Meeting Minutes December 19, 2018 7:00 p.m.**

### **CALL THE MEETING TO ORDER WITH THE PLEDGE OF ALLEGIANCE.**

Truxton Town Board Regular Monthly Meeting was called to order by Supervisor Lloyd Sutton, Jr. at the Truxton Town Office, Historic Train Depot, on December 19, 2018 at 7:00 p.m.

### **APPROVAL OF MINUTES**

Motion to approve November minutes with changes was made by Molly McDermott. Second motion was made by PJ Dwyer. All in favor.

### **PRIVILEGE OF THE FLOOR**

Jeff Reakes stated the prospect for the new Highway employee turned down the position. Second prospect, Aric Harvey was offered the position. The Board approved to keep the rate of \$18.50/hr with 3 Vacation Days (until Dec 31, 2018) for new hire. Motion to approve was made by Molly McDermott. Second was made by PJ Dwyer. All in favor.

Lloyd stated the Youth Grant for 2019 is \$2600. Community Center Christmas Party, Levi Sutton helped kids create and print 3D ornaments. Possible to use grant to purchase new 3D Printer.

Rich Ryan brought it to the Boards attention there are 2 blind spots at the Community Center and asked for stop signs to be put up. The Board and Highway Superintendent are going to update the florescent speed signs and install a Stop Sign exiting the Community Center lot.

Jeff Reakes informed the Board that the Ford 440 truck will not run, possibly needs a new starter. Will have it diagnosed.

Jeff Reakes informed the Board the Transfer Station truck needs to have 2 injectors replaced. The price to have Contentos manage trucking is set to \$250/pull. Also, one of the transfer stations attendants has to take some time off and they are looking for a new hire. Jeff has a prospect in mind.

Lloyd passed out Transfer to Reserve Funds spreadsheet to the Board. Motion to approve transfers was made by PJ Dwyer. Second motion was made by Molly McDermott. All in favor.

The Town Code Officer left his December report for the Board. Board looking for more action to be enforced.

### **LED STREET LIGHTING AND HIGHWAY DEPARTMENT LIGHTING**

Jeff Reakes and Lloyd received 3 quotes for LED lighting. Eastern Solutions provided a quote with different numbers that were not clear to understand. Gathering more info and proposal for new lighting for January meeting.
